PAYMENT OF PROGRAM FEES

Initial

PROGRAM FEES ARE DUE IN FULL ON THE 1ST DAY OF EACH MONTH.
DISCOUNTED PAYMENT FOR THE FULL SEASON MUST BE RECEIVED ON OR BEFORE SEPTEMBER 1, 2020.

I AGREE TO PAY PROGRAM FEES ON TIME, WHICH IS ON OR BEFORE THE 1ST DAY OF THE MONTH OF CLASSES.
FOR EACH LATE PAYMENT, I WILL AUTOMATICALLY ADD A PROCESSING FEE OF \$ 40.

PROGRAM REQUIREMENTS

HIGH PERFORMANCE CLASSES ARE OFFERED FOUR TIMES PER WEEK, MONDAY - THURSDAY. ATTENDANCE OF ALL FOUR CLASSES PER WEEK AND COMPETITION ON SUNDAYS IS REQUIRED. PLEASE INFORM COACHES ABOUT ALL NECESSARY ABSENCES.

HIGH PERFORMANCE STUDENTS ARE REQUIRED TO TAKE AT LEAST 2 (TWO) INDIVIDUAL LESSONS PER WEEK. IT IS THE FENCER'S RESPONSIBILITY TO SCHEDULE THEIR LESSONS. EACH LESSON LASTS 25 MINUTES AND COSTS \$50. LESSONS THAT ARE NOT CANCELED AT LEAST 24 HOURS IN ADVANCE HAVE TO BE PAID IN FULL.

MEMBERS OF THE HIGH PERFORMANCE PROGRAM ARE REQUIRED TO ATTEND THE COMPLETE USA FENCING NATIONAL TOURNAMENT CIRCUIT FOR THEIR AGE GROUP (NACS, JUNIOR OLYMPICS, SUMMER NATIONALS).
